Description of Material Information or Fact	<p>Please be informed that we have received an official copy of the Court Order from the Jakarta High Court No. 374/PDT/2016/PT.DKI towards the court order on civil law suit No. 197/Pdt.G/2014/PN.Jkt.Sel filed by Prof. Dr. O.C. Kaligis S.H., MH. (Appellant/ formerly Plaintiff) against, among others, Dr. H. Purnomo Prawiro Mangkusudjono (Appellee I/ formerly Defendant I), Bayu Priawan Djokosoetono (Appellee II/ formerly Defendant II), Dr. Sri Adriyani Lestari (Appellee III / formerly Defendant III), Minister of Laws and Human Rights of Republic of Indonesia (Appellee V/ formerly Defendant V), PT Blue Bird Taxi (Co-Appellee I/ formerly Co-Defendant I), Dr. Mintarsih A. Latief (Co-Appellee II/ formerly Co-Defendant II) and PT Blue Bird (Co-Appellee III/ formerly Co-Defendant III) ("Lawsuit 197") with court order, among others as follows:</p> <ol style="list-style-type: none">1. To reinforce court order of South Jakarta District Court No.197/Pdt.G/2014/PN.Jkt.Sel dated December 8, 2014 which was lodged for an appeal;2. To sentence Appellant formerly Plaintiff, to pay court fees for two levels of court, in the high court level, in the amount of Rp.150,000 (one hundred and fifty thousand Rupiahs). <p>Lawsuit 197 was filed on April 4, 2014 on the basis that the Plaintiff has lost his income as the result of the revocation of his Power of Attorney to represent Co-Defendant II in the Lawsuit No.311 (dated May 17, 2013) which he considered to be against the law and caused him losses.</p> <p>Previously the South Jakarta District Court on December 8, 2014 has given court order upon this Lawsuit 197 as follows: In Demurrer (<i>Eksepsi</i>)</p> <ol style="list-style-type: none">1. To accept demurrer (<i>eksepsi</i>) from Defendant I, II, III and V, as well as Co-Defendant I and III partially;2. To state that the District Court is not authorized to review and adjudicate the case.

		<p>In the Primary of the Case:</p> <ol style="list-style-type: none"> 1. To state that the Plaintiff's lawsuit cannot be accepted; 2. To sentence the Plaintiff to pay court fees in the amount of Rp.2,816,000 (two million and eight hundred sixteen thousand Rupiahs).
